



I-Suite 10.01.01 Release Notes

Date: Jul 28, 2010
Version: I-Suite Version 10.01.01

Description: The primary focus of this release is to implement additional security requirements, update the database engine to MS SQL Server 2005 Express, and to fix several outstanding application defects.

Important things to know prior to installing I-Suite (General)

- The Full Server and Full Client install can both be installed mid-incident. Run a backup of your database prior to updating I-Suite.
- System Administrative privileges **are** required to install the application. They are **not** required to run the application.
- The new database version is 10.01.01. Previous databases will be automatically updated to the new database version the first time the database is connected to the server computer. This may take several minutes, depending on the size of database.
- Install the same version of I-Suite on all server and client computers.
- Close the I-Suite application and all related windows on the local computer and uninstall previous versions of I-Suite before installing this program.

Important things to know prior to installing version 10.01.01 (Full Server and Full Client)

- System Administrative privileges **are** required to properly install the full I-Suite Server and the full Client installations. You must reboot after the installation is finished and re-login with System Administrative privileges for the install to complete.
- All previous versions of I-Suite must be uninstalled before installing I-Suite Version 10.01.01. Update installers of version 10.01.01 are not available.
- Use the Uninstall I-Suite option from the I-Suite program group in the Start/All Programs menu to remove previous versions of I-Suite.
- After removing the I-Suite full server application from a computer, delete the c:\program files\isuite\bin folder if it still exists.
- The SQL Server Manager icon will no longer display in the system tray. After installing I-Suite version 10.01.01, the SQL Server Manager can be accessed from a shortcut on the desktop named SQL Server Manager.
- To set up the I-Suite server, on the Login Screen, click the "Initial Server Setup" button. This will launch a New User screen where you must create the initial Admin User.

The Demob calculation of Number of Days left will be based on the system date not the tentative release date. (i.e. Demob Date – System Date = Number of Days Left)
