Subject: I-Suite Application Version 10.01.02

Version 10.01.02 of the I-Suite Application is now available for download at <http://isuite.nwcg.gov>. This release includes Version 10.01.02 and Patch 10-1.

The primary focus of this release is to address a major installation issue. The installer also includes all changes in I-Suite Patch 10-1, which corrects recently identified application issues. The Release Notes are posted on the I-Suite Web Site.

The Full Server and Full Client install can be installed mid-incident. Run a backup of your database prior to updating I-Suite.

System Administrative privileges **are** required to properly install the full I-Suite Server and the full Client installations. A reboot **must** be performed after the installation is finished and re-login with System Administration privileges for the install to complete. All previous versions of I-Suite (version 9.xx.xx and earlier) must be uninstalled before installing I-Suite Version 10.01.02. Updated installers of version 10.01.02 are not available. **Important Note:** If 10.01.01 is installed, only Patch 10-1 is necessary.
